MAXIMUM TOWING RATES FOR LICENSED POLICE TOWING COMPANIES
AUTHORIZED UNDER ARTICLE 11, ANNE ARUNDEL COUNTY CODE

- 1) **Towing Fee** – Vehicle Impound, fee includes positioning, dolly if necessary, securing a collision, clean-up debris, including absorbent.
 - GVWR of towed vehicle, up to 10,000 lbs. **\$185**
 - GVWR of towed vehicle, from 10,001 - 19,500 lbs. **\$270**
 - GVWR of towed vehicle, over 19,500 lbs. **\$800**
- 2) **Evidence Impound Fee** – a vehicle taken to a designated police facility **\$185**
- 3) **Winching Fee** – a winched vehicle must be more than 20 feet from the roadway or require righting or lifting, returning it to the roadway
 - GVWR of towed vehicle, up to 10,000 lbs. **\$.50 setup + \$40 per ¼ hour**
 - GVWR of towed vehicle, from 10,001 - 19,500 lbs. **\$.75 setup + \$60 per ¼ hour**
 - GVWR of towed vehicle over 19,500 lbs **Market Rate** (submitted and approved by Police Department)
- 4) **Storage Fee** - begins the first calendar day following the tow service. Calendar day is defined at 12:01am.
 - **\$25 /day** (light duty car or truck)
 - **\$50/day** (GVWR over 19,500 or vehicle in excess of 20ft)
- 5) **Administrative Fee** – one-time administrative filing fee for vehicles towed. **\$25**
- 6) **Waiting Time** - time accrued by a tow truck operator while on the scene when delayed by activities of the Police Department. Only applies after the first 15 minutes (¼ hour) waiting on the scene or for cleanup time in excess of 15 minutes.
 - GVWR of up to 10,000 lbs. **\$15 per ¼ hour**
 - GVWR from 10,001 - 19,500 lbs. **\$25 per ¼ hour**
 - GVWR over 19,500 lbs **Market Rate** (submitted and approved by Police Department)
- 7) **Extra Services** –when necessary for the job. Justification noted on the tow form by an officer and well documented.
 - **Extra Truck** **\$(50% of towing fee for the class)**
 - **Extra Person** **\$25 base + \$5 per ¼ hr**
 - **Extraordinary Recovery Fee** - must be fully documented with photos **Market Rate** (submitted and approved by Police Department)
- 8) **Declared Emergency** – surcharge applicable only during a county declared weather emergency or other situations when declared by Police Department. **+\$25%** (for towing and winching only)
- 9) **Dispatch Management Fee** – Towing management system software **\$31**
- 10) **Cancellation / Road Service Fee** - Change tire, jump start, lockout or cancellation of tow truck on scene **\$50**
- 11) **Window Taping Fee** - to secure vehicle from additional interior damage during storage **\$ 10 per window /\$ 50 max**
- 12) **Key Fee** – ignition key unavailable for towed vehicle **\$25**
- 13) **Mileage**–for vehicles towed in excess of 5 miles to a designated police facility **\$4 / mile**

THIS SCHEDULE OF FEES IS THE MAXIMUM ALLOWABLE FEES THAT MAY BE CHARGED FOR POLICE REQUESTED TOWING.

THIS FEE SCHEDULE MUST BE KEPT AVAILABLE IN ALL TOWING VEHICLES, PRESENTED TO VEHICLE OWNERS UPON REQUEST AND CONSPICUOUSLY POSTED AT ALL PLACES OF BUSINESS LICENSED FOR POLICE TOWING BY ANNE ARUNDEL COUNTY.
