4	FOR the purpose of amending the Capital Budget by reducing the appropriation of funds
5	from the Information Technology Enhance capital project, Project No. C519600; and
6	amending the Capital Program and Capital Projects Bond Ordinance for the fiscal
7	year ending June 30, 2017.

13	WHEREAS, the Information Technology Enhance capital project, Project No.
14	C519600, has an existing appropriation in the Capital Budget for the fiscal year
15	ending June 30, 2017, and includes an appropriation of funds that have previously
16	been paid directly to vendors by the Emergency Numbers Service Board; and

18	WHEREAS, Section 716 of the Charter authorizes the County Council, upon
19	request of the County Executive and by affirmative vote of five members of the
20	County Council, to amend the Capital Budget; and

22	WHEREAS, the County Executive has recommended a reduction of the
23	appropriation to the Information Technology Enhance capital project, Project No.
24	C519600 for the current fiscal year in the amount that has been previously paid to
25	vendors by the Emergency Numbers Service Board; and

1 WHEREAS, in accordance with Section 716 of the Charter, the Planning 2 Advisory Board has recommended this amendment to the Capital Budget; now, 3 therefore, 4 5 SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland, That the Capital Budget for the fiscal year ending June 30, 2017, is hereby 6 7 amended by reducing the appropriation to the Information Technology Enhance capital project, Project No. C519600 from the "Miscellaneous" funding source in the amount of 8 9 \$3,511,000. 10 11 SECTION 2. And be it further enacted, that the Capital Program and the Capital 12 Projects Bond Ordinance for the fiscal year ending June 30, 2017, are hereby amended in 13 accordance with the provisions of this Ordinance. 14 15 SECTION 3.
