| 4 | WHEREAS, the WB & A Trail capital project, Project No. P393600, and the Turf |

| 18 | WHEREAS, additional funding has become available from a Maryland Bikeways |

| 21 | WHITEDEAS Sections 710 and 716 after Chapter and having the County Council among |
| 22 | WHEREAS, Sections 712 and 716 of the Charter authorize the County Council, upon |
| 23 | request of the County Executive and by affirmative vote of five members of the |
| 24 | County Council, to amend the Capital Budget and to increase the total amount of |

appropriations to the capital budget from revenues not anticipated in the budget for 1 the current fiscal year; and 2 3 WHEREAS, the County Executive is requesting that \$400,000 from the Maryland 4 Bikeways Program grant be appropriated to the capital project, WB & A Trail, 5 Project No. P393600; and 6 7 WHEREAS, Section 711(b) of the Charter authorize the County Council, upon 8 request of the County Executive, to transfer appropriations between capital projects 9 in the Capital Budget; and . 10 11 WHEREAS, the County Executive is requesting that \$400,000 be transferred from 12 the WB & A Trail capital project, \$100,000 be transferred from the New Eastern PS 13 capital project, and \$150,000 be transferred from the Replace Fire Dept Pagers 14 capital project to the Turf Fields in Regional Parks capital project, Project No. 15 P561700; and 16 17 WHEREAS, in accordance with Section 716 of the Charter, the County Executive 18 and the Planning Advisory Board have requested and recommended these 19 amendments to the Capital Budget; and 20 21 WHEREAS, the Controller has certified in writing that such funds are available for 22 appropriation; and 23 24 WHEREAS, Section 307(i) of the Charter authorizes the County Council to increase 25 the funding for capital projects by emergency ordinance so long as the increases are 26 required solely to meet cost escalation and do not affect the scope of the project, and 27 the County Council has determined these criteria to be met; now, therefore, 28 29 SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland, 30 That the Capital Budget for the fiscal year ending June 30, 2014, is hereby amended by 31 making an additional appropriation in the amount of \$400,000 from the Maryland Bikeways 32 Program grant, which was not anticipated in the budget for the fiscal year ending June 30, 33 2014, to the WB & A Trail capital project, Project No. P393600. 34 35 SECTION 2. And be it further enacted, That the Capital Budget for the fiscal year 36 ending June 30, 2014, is hereby amended by transferring appropriations in the total amount 37 of \$650,000 from the following capital projects: 38 39 40 WB & A Trail, Project No. P393600 400,000 (General County Bonds) 41 New Eastern PS, Project No. F507600 42 (Bond Premium) 100,000 43 Replace Fire Dept Pagers, Project No. F550500 44
