A BILL ENTITLED

1 AN ORDINANCE concerning: Capital Budget and Program – Demo Bldg Code/Health –  
2 Amending Scope and Description of Project

3  
4 FOR the purpose of amending the Capital Budget by amending the scope and description of  
5 the Demo Bldg Code/Health capital project; amending the Capital Program and Capital  
6 Projects Bond Ordinance; and generally relating to the Demo Bldg Code/Health capital  
7 project.

9 BY amending: Capital Budget  
10 Capital Program  
11 Capital Projects Bond Ordinance

13 WHEREAS, Section 716 of the Charter authorizes the County Council, upon request  
14 of the County Executive and by affirmative vote of five members of the County  
15 Council to amend the capital budget; and

16  
17 WHEREAS, the County Executive is requesting that the scope and description of the  
18 Demo Bldg Code/Health capital project, Capital Project No. C206500 be amended to  
19 include the abatement of zoning violations when permitted by order of court in an  
20 action to enforce provisions of Article 18 of the County Code; and

22 WHEREAS, in accordance with Section 716 of the Charter, the Planning Advisory  
23 Board has recommended this amendment to the Capital Budget; now, therefore,


1 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*  
2 That the Capital Budget for the fiscal year ending June 30, 2016, is hereby amended by  
3 changing the name of the Demo Bldg Code/Health capital project, Capital Project No.  
4 C206500, to "Demo Bldg Code/Health/Zoning Violation Abatement", and by revising the  
5 scope and description of the project by including the following: "This project also includes  
6 funds for the abatement of zoning violations when permitted by an order of court in an action  
7 to enforce provisions of the County Code."  
8

9 SECTION 2. *And be it further enacted,* That the Capital Program and Capital Projects  
10 Bond Ordinance are hereby amended in accordance with the provisions of this Ordinance.


12 SECTION 3. *And be it further enacted,* That this Ordinance shall take effect 45 days




