A BILL ENTITLED

1 AN ORDINANCE concerning: Public Works – Utilities – Metered Water and
2 Wastewater Charges

4 FOR the purpose of decreasing rates for water and wastewater charges; providing for the
5 effective date of this Ordinance; and generally related to utilities.

7 BY repealing and reenacting, with amendments: § 13-5-805(b)
8 Anne Arundel County Code (2005, as amended)

10 SECTION 1. *Be it enacted by the County Council of Anne Arundel County,*
11 *Maryland,* That Section(s) of the Anne Arundel County Code (2005, as amended) read as
12 follows:

13 ARTICLE 13. PUBLIC WORKS

14 TITLE 5. UTILITIES

15 16 17 18 13-5-805. Metered water and wastewater charges.

19 (b) **Charges.** The charge for each 1,000 gallons of water usage is [~~\$2.56~~] \$2.70 for
20 water and [~~\$4.49~~] \$4.74 for wastewater. For the fiscal year beginning [July 1, 2011] JULY
21 1, 2016, and for each fiscal year thereafter, the County Executive shall set the charges for
22 water and wastewater usage in accordance with § 4-11-105 of this Code and may increase
23 the charges in an amount not to exceed 5.00% of the then current charges. Any increase
24 in charges in an amount greater than 5.00% shall be set by the County Council by
25 ordinance. There is an account maintenance charge of \$6.00 per billing cycle regardless
26 of the amount of usage.

EXPLANATION: CAPITALS indicate new matter added to existing law.
[Brackets] indicate matter stricken from existing law.

1 SECTION 2. *Be it further enacted*, that this Ordinance shall take effect on September
2 1, 2015.




