10	SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland,		
11	That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

15	TITLE 1. CLASSIFIED SERVICE

17	6-1-201. Titles; pay grades; work weeks; minimum qualifications.

19	(d) Title, pay grades, work week, and minimum qualifications. The title, minimum		
20	standards, pay grade, and the work week designation that an employee is required to follow		
21	for each class within the classified service are as follows:

*** Manager, Safety and Insurance	[NR20C] NR21C	Graduation from an accredited four-year college or university with major course work in business administration; considerable experience with risk management or insurance programs; and a valid non-commercial Class C motor vehicle operator's license

SECTION 2. And be it further enacted, That the provisions of this Ordinance shall apply the first full pay period beginning on or after July 1, 2015.
