20 (6) IN SECTION 702.4(B)(2)(A), AFTER "EQUIPMENT.", INSERT:



22 6500 WATTS SHALL BE INCLUDED IN THE FULL LOAD CALCULATION IF A COUNTY
23 OWNED AND MAINTAINED SEWAGE EJECTOR OR GRINDER PUMP IS CONNECTED TO
24 AN OPTIONAL STANDBY SYSTEM.

1 SECTION 2. *And be it further enacted*, That this Ordinance shall take effect 45 days
2 from the date it becomes law.






