10	Debt Management Policy for Anne Arundel County dated September 1, 2015,
11	which was prepared by the Controller and approved by the County Executive; and

13	WHEREAS, the Controller has made changes to the Debt Management Policy
14	resulting in a revised Debt Management Policy dated July 5, 2016; and

16	WHEREAS, the County Executive has determined that the revised Debt
17	Management Policy for Anne Arundel County dated July 5, 2016, incorporated
18	herein by reference as if fully set forth, meets the requirements of State law and
19	local law and the needs of the governmental entity, has approved the revised Debt
20	Management Policy for Anne Arundel County dated July 5, 2016, and now
21	submits it to the County Council for adoption; and

23	WHEREAS, as required by the Local Government Article, § 17-207, of the State
24	Code, the County Council finds that the revised Debt Management Policy dated
25	July 5, 2016, meets the requirements of State law and local law and the needs of
26	the governmental entity, and desires to adopt the revised Debt Management
27	Policy dated July 5, 2016; now, therefore, be it
