1       RESOLUTION appointing and reappointing members to the Anne Arundel County Adult  
2 Public Guardianship Review Board

3  
4       WHEREAS, the Family Law Article, § 14-402, of the State Code requires that the  
5 Anne Arundel Adult Public Guardianship Review Board consist of 11 members  
6 appointed by the county executive with the advice and consent of the county council;  
7 and

8  
9       WHEREAS, the Family Law Article, § 14-402(a)(2), of the State Code requires that,  
10 of the 11 members, one shall be a professional representative of a local department of  
11 social services; one shall be a physician's assistant, nurse practitioner, or physician  
12 who is not a psychiatrist; one shall be a psychiatrist; one shall be a representative of a  
13 local commission on aging; one shall be a professional representative of a local  
14 nonprofit social service organization; one shall be a lawyer; two shall be lay  
15 individuals; one shall be a registered nurse; one shall be a professional in the field of  
16 disabilities; and one shall be a person with a physical disability; and

18       WHEREAS, the Family Law Article, § 14-402(b), of the State Code provides that the  
19 term of a member is three years, that at the end of a term, a member continues to  
20 serve until a successor is appointed and qualifies, and that a member who is  
21 appointed after a term has begun serves only for the rest of the term and until a  
22 successor is appointed and qualifies; and

24       WHEREAS, the terms of various members have expired or the members have  
25 resigned before the expiration of their terms; and

26  
27       WHEREAS, the County Executive, subject to the advice and consent of the County  
28 Council, has appointed the following individuals to serve the indicated terms:

29  
30       (1) John McDonald, M.D., a psychiatrist, to the remainder of a term ending  
31 December 31, 2018;

33       (2) Linda L. Dennis, a representative of a local commission on aging, to the  
34 remainder of a term ending August 31, 2018; and

1 (3) Pamela J. Luby-Smith, a lay individual, to the remainder of a term ending July  
2 30, 2018; and

4 WHEREAS, the County Executive, subject to the advice and consent of the County  
5 Council, has reappointed the following individuals to serve the indicated terms:

7 (1) Robin L. Scherzo, L.S.W.A., a professional representative of a local  
8 nonprofit social service organization, to a term ending August 31, 2018;

9  
10 (2) Blair E. Alexander, a lay individual, to a term ending August 31, 2018;

11  
12 (3) Ellen Marie Miller, R.N., a registered nurse, to a term ending December 31,  
13 2018; and

14  
15 (4) Julie Klunk Provan, professional in the field of disabilities, to a term ending  
16 on August 31, 2018; and



18 WHEREAS, the County Council, after public hearing, finds that John McDonald,  
19 M.D., Linda L. Dennis, Pamela J. Luby-Smith, Robin L. Scherzo, L.S.W.A., Blair E.  
20 Alexander, Ellen Marie Miller, R.N., and Julie Klunk Provan meet the eligibility  
21 requirements under the Family Law Article, § 14-402, of the State Code and are  
22 qualified to serve on the Anne Arundel County Adult Public Guardianship Review  
23 Board; now, therefore, be it

25 *Resolved by the County Council of Anne Arundel County, Maryland,* That it hereby  
26 approves the appointment of John McDonald, M.D., a psychiatrist, to serve the remainder of  
27 a term ending December 31, 2018; the appointment of Linda L. Dennis, a representative of a  
28 local commission on aging, to serve the remainder of a term ending August 31, 2018; the  
29 appointment of Pamela L. Luby-Smith, a lay individual, to serve the remainder of a term  
30 ending July 30, 2018; the reappointment of Robin L. Scherzo, L.S.W.A., a professional  
31 representative of a local nonprofit social service organization, to serve a term ending August  
32 31, 2018; the reappointment of Blair E. Alexander, a lay individual, to serve a term ending  
33 August 31, 2018; the reappointment of Ellen Marie Miller, R.N., a registered nurse, to serve  
34 a term ending December 31, 2018; and the reappointment of Julie Klunk Provan, a  
35 professional in the field of disabilities, to serve a term ending on August 31, 2018; and be it
