By the County Council, September 21, 2015

1 RESOLUTION approving the acceptance of a grant from the Maryland Department of
2 Health and Mental Hygiene's Behavioral Health Administration for funds that were awarded
3 to it for the benefit of the County under a Federal grant entitled Targeted Capacity Expansion:
4 Medication Assisted Treatment – Prescription Drug and Opioid and recognizing the County
5 Executive's authority to act in connection with the grant.

7 WHEREAS, the Maryland Department of Health and Mental Hygiene, Behavioral
8 Health Administration applied to the Substance Abuse and Mental Health Services
9 Administration for a grant entitled Targeted Capacity Expansion: Medication Assisted
10 Treatment – Prescription Drug and Opioid (the "Application"); and

12 WHEREAS, in response to the Application, the Maryland Department of Health and
13 Mental Hygiene, Behavioral Health Administration was awarded Federal Grant
14 Number 1H79TI026148-01; and
15

16 WHEREAS, the Application listed Anne Arundel County as a high-risk community to
17 be addressed by the grant, and
18

19 WHEREAS, as part of the grant award, the Maryland Department of Health and
20 Mental Hygiene, Behavioral Health Administration was awarded \$227,908 for
21 projects in Anne Arundel County; and

23 WHEREAS, the Maryland Department of Health and Mental Hygiene, Behavioral
24 Health Administration has notified the Anne Arundel County Department of Health of
25 the award and its intent to grant funds totaling \$227,908 to the County subject to the
26 completion and submission of a Budget Justification; and

28 WHEREAS, under the Application and Budget Justification, the County is required to
29 provide \$0 in matching funds; and

31 WHEREAS, the Anne Arundel County Department of Health is the agency that will
32 administer the expenditure of the grant; and

34 WHEREAS, the County Executive has requested that the County Council approve
35 the award; and

1 WHEREAS, Section 306 of the Anne Arundel County Charter provides that the
2 County Council shall have the power to accept gifts and grants; now, therefore be it
3

4 *Resolved by the County Council of Anne Arundel County, Maryland,* That it approves the
5 utilization of the award from the Maryland Department of Health and Mental Hygiene,
6 Behavioral Health Administration from the grant entitled Targeted Capacity Expansion:
7 Medication Assisted Treatment – Prescription Drug and Opioid in the amount of \$227,908
8 with \$0 matching funds, which grant is to be administered by the Anne Arundel County
9 Department of Health; and be it further

10
11 *Resolved,* That the County Council recognizes that the County Executive or the County
12 Executive's designee is duly authorized to act in connection with the grant; and be it further
13

14 *Resolved,* That a copy of this Resolution be sent to County Executive Steven R. Schuh.


