A BILL ENTITLED

1 AN ORDINANCE concerning: Anne Arundel County Consolidated Plan FY 2016 - FY  
2 2020

3  
4 FOR the purpose of adopting the “Anne Arundel County Consolidated Plan FY 2016 - FY  
5 2020”.

6  
7 WHEREAS, the U.S. Department of Housing and Urban Development (HUD)  
8 requires that local governments develop Consolidated Plans that identify local  
9 housing and community development needs and that further establish goals and  
10 strategies to address those needs; and

11  
12 WHEREAS, an approved Consolidated Plan serves as the framework to identify  
13 housing and community development programs that may benefit from HUD grant  
14 programs; and

15  
16 WHEREAS, under 24 CFR Part 91, local governments are required to submit to  
17 HUD for final approval a Consolidated Plan that describes “its plan to pursue these  
18 goals for all the community planning and development programs, as well as for  
19 housing programs”; and

21 WHEREAS, the “Anne Arundel County Consolidated Plan FY 2016 - FY 2020”  
22 has been drafted to fulfill the requirements of the provisions of 24 CFR Part 91;  
23 now, therefore,



25 SECTION 1. *Be it enacted by the County Council of Anne Arundel County,*  
26 *Maryland,* That the “Anne Arundel County Consolidated Plan FY 2016 - FY 2020” is  
27 hereby approved and adopted.

1 SECTION 2. *And be it further enacted*, That the "Anne Arundel County  
2 Consolidated Plan FY 2016 - FY 2020" is incorporated herein by reference as if fully set  
3 forth, and a certified copy of the "Anne Arundel County Consolidated Plan FY 2016 -  
4 FY 2020" shall be permanently kept on file at the Office of the Administrative Officer to  
5 the County Council and in the principal office of Arundel Community Development  
6 Services, Inc.

8 SECTION 3. *And be it further enacted*, That this Ordinance shall take effect 45 days  
9 from the date it becomes law.


