## A BILL ENTITLED

1	AN ORDINANCE concerning: Ethics – Conflicts of Interest
2	
3	FOR the purpose of prohibiting County employees from assisting or representing parties
4	for contingent compensation in any matter before the County; making technical
5	corrections; and generally relating to ethics.
6	
7	FOR the purpose of excluding non-compensated board and commission members from the
8	prohibition against employees representing or assisting others in certain matters:
9	prohibiting non-compensated board and commission members from assisting or
10	representing a person for contingent compensation in certain matters; and generally
11	relating to ethics.

13	BY repealing and reenacting, with amendments: § 7-5-104
14	Anne Arundel County Code (2005, as amended)

16	SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland,
17	That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

19	ARTICLE 7 PUBLIC ETHICS
