A BILL ENTITLED

1 AN ORDINANCE concerning: Current Expense Budget – Transfer of Funds – Chief  
2 Administrative Officer – Contingency Account – Orphans Court

3  
4 FOR the purpose of transferring an appropriation of funds from the Contingency Account  
5 of the Chief Administrative Officer to the Orphans Court for the payment of the  
6 settlement of a lawsuit concerning health benefits for an Orphans Court judge.

8 BY amending: Current Expense Budget

9  
10 WHEREAS, under Section 711(a) of the Charter, upon recommendation of the  
11 County Executive, the County Council may transfer funds between offices,  
12 departments, institutions, boards, commissions or other agencies of the County  
13 government and within the same fund of the Current Expense Budget; and

14  
15 WHEREAS, under Section 712 of the Charter, upon recommendation of the  
16 County Executive, the County Council may make supplementary appropriations  
17 from contingent funds, provided that the Controller shall first certify in writing  
18 that such funds are available for such appropriation; and

20 WHEREAS, the County Executive has made a recommendation that \$14,300  
21 from the FY2016 appropriation to Chief Administrative Officer, Contingency, be  
22 transferred to the Orphans Court; and

24 WHEREAS, the Controller has certified in writing that such funds are available  
25 for appropriation; now therefore,

1 SECTION 1. *Be it enacted by the County Council of Anne Arundel County,*  
2 *Maryland,* That the Current Expense Budget for the fiscal year ending June 30, 2016, be  
3 and it is hereby amended by transferring from the below-listed department in the amount  
4 set forth:

6 Chief Administrative Office – General Fund Appropriation  
7 Contingency  
8 Grants, Contributions & Other \$ 14,300

10 to the below-listed department in the amount set forth:

12 Orphans Court – General Fund Appropriation  
13 Orphans Court  
14 Personal Services \$ 14,300


16 SECTION 2. *And be it further enacted,* That this Ordinance shall take effect 45 days
