A BILL ENTITLED

1 AN ORDINANCE concerning: Personnel – Exempt Service – County Contractual Positions
2 Assigned to the Anne Arundel County Department of Social Services

4 FOR the purpose of placing certain County contractual positions assigned to the Anne
5 Arundel County Department of Social Services that are funded in whole or in part by
6 State or federal funds in the exempt service; providing for the manner of compensation;
7 making certain changes to the Miscellaneous Exempt Employees Pay and Benefit Plan;
8 and generally relating to Personnel.

10 BY repealing and reenacting, with amendments: §§ 5-3-103(c); 6-2-103; and 6-2-106
11 Anne Arundel County Code (2005, as amended)

12 SECTION 1. *And be it further enacted*, That Section(s) of the Anne Arundel County
13 Code (2005, as amended) read as follows:

20 **5-3-103. Participants.**

EXPLANATION: CAPITALS indicate new matter added to existing law.

1 (c) **Employees not eligible.** The following employees are not eligible to be participants
2 in the plan:

4 (1) employees hired on a part-time basis with scheduled hours less than 50% of the
5 amount of time specified for the position;

7 (2) [an employee] EMPLOYEES hired on a temporary basis; and

9 (3) [an employee] EMPLOYEES hired under the provisions of [§ 6-2-106 of this Code
10 and either] § 802(a)(14) or § 802(a)(17) of the Charter OR § 6-2-103(B) OF THIS CODE.

16 **6-2-103. Additional exempt positions.**

17
18 (A) **Additional positions by title.** [In addition to the positions established in § 802 of the
19 Charter for the exempt service, there are the following positions in the exempt service whose
20 number and classification are approved as part of the annual budget and appropriation
21 ordinance, that] IN ACCORDANCE WITH § 802(B) OF THE CHARTER THE POSITIONS DESCRIBED
22 IN THIS SUBSECTION ARE ESTABLISHED AS POSITIONS IN THE EXEMPT SERVICE THAT ARE IN
23 ADDITION TO THE POSITIONS ESTABLISHED BY § 802(A) OF THE CHARTER, WITH THE
24 COMPENSATION FOR THE POSITIONS SET FORTH IN THE EXEMPT PAY AND BENEFIT PLAN.
25 UNLESS OTHERWISE PROVIDED BY THIS SUBSECTION THE NUMBER OF POSITIONS UNDER
26 EACH TITLE DESCRIBED IN THIS SUBSECTION SHALL BE APPROVED AS PART OF THE ANNUAL
27 BUDGET AND APPROPRIATION ORDINANCE AND may not be changed during a fiscal year
28 except as approved by ordinance of the County Council. THE POSITIONS ARE:

31 (B) **Additional positions by nature of funding source.** POSITIONS NOT IN THE
32 CLASSIFIED SERVICE THAT ARE ASSIGNED TO THE ANNE ARUNDEL COUNTY DEPARTMENT
33 OF SOCIAL SERVICES AND FUNDED IN WHOLE OR IN PART BY STATE OR FEDERAL FUNDS
34 OTHER THAN GRANT FUNDS ARE ESTABLISHED AS ADDITIONAL POSITIONS IN THE EXEMPT
35 SERVICE. THE COMPENSATION FOR THE POSITIONS SHALL BE SET FORTH IN WRITTEN
36 AGREEMENTS IN ACCORDANCE WITH THE MISCELLANEOUS EXEMPT EMPLOYEES PAY AND
37 BENEFIT PLAN. THIS PROVISION DOES NOT PRECLUDE THE COUNTY FROM ALSO ASSIGNING
38 POSITIONS IN THE CLASSIFIED SERVICE OF THE COUNTY TO THE ANNE ARUNDEL COUNTY
39 DEPARTMENT OF SOCIAL SERVICES.


41 **6-2-106. Miscellaneous exempt employees pay and benefit plan.**

43 An [exempt] employee in an hourly rate position or in a State or federal grant-funded
44 position THAT IS IN THE EXEMPT SERVICE PURSUANT TO § 802(B)(14) OR (17) OF THE
45 CHARTER OR IN A POSITION ASSIGNED TO THE DEPARTMENT OF SOCIAL SERVICES THAT IS
46 IN THE EXEMPT SERVICE PURSUANT TO § 6-2-103(B) OF THIS CODE shall receive pay and
47 benefits as specified in a written agreement between the employee and the [appointing
48 authority] COUNTY and in accordance with available appropriations in the annual budget and
49 appropriation ordinance.

1 SECTION 2. *And be it further enacted,* That this Ordinance shall take effect 45 days
2 from the date it becomes law.


