A BILL ENTITLED

1 AN ORDINANCE concerning: Real Property Taxes – Deferral for Elderly or Disabled
2 Homeowners

4 FOR the purpose of increasing the ceiling on gross income for eligibility for the real
5 property tax deferral applicable to certain elderly or disabled homeowners; providing
6 for the applicability of this Ordinance; and generally related to real property taxes.

8 BY repealing and reenacting with amendments: § 4-2-203(c)
9 Anne Arundel County Code (2005, as amended)

11 SECTION 1. *Be it enacted by the County Council of Anne Arundel County,*
12 *Maryland,* That Section(s) of the Anne Arundel County Code (2005, as amended) read as
13 follows:

15 **ARTICLE 4. FINANCE, TAXATION AND BUDGET**

17 **TITLE 2. REAL PROPERTY TAXES**

19 **4-2-203. Deferral for elderly or disabled homeowners.**

21 (c) **Ceiling on gross income.** Homeowners are eligible if their combined gross
22 income, as defined in the Tax-Property Article, § 9-104, of the State Code, does not
23 exceed [~~\$50,000~~] \$55,000 per year.



1 SECTION 2. *And be it further enacted*, That this Ordinance shall not apply to an
2 Agreement under §4-2-203(j) of the Anne Arundel County Code (2005, as amended) that
3 was executed before the effective date of this Ordinance


