A BILL ENTITLED

1 AN ORDINANCE concerning: Animal Control – Food and Water

3 FOR the purpose of amending the requirements for food and water for animals; and generally
4 relating to the care and keeping of animals.

6 BY repealing and reenacting, with amendments: § 12-4-802
7 Anne Arundel County Code (2005, as amended)

9 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
10 That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

12 **ARTICLE 12. PUBLIC SAFETY**

14 **TITLE 4. ANIMAL CONTROL**

16 **12-4-802. Food and water required.**

18 Animals shall be provided with daily food and WITH water[,] AT ALL TIMES. FOOD AND
19 WATER SHALL BE free of visible contamination[, that is]. FOOD SHALL BE wholesome,
20 palatable, and of sufficient quantity and nutritive value to meet the normal daily requirements

EXPLANATION: CAPITALS indicate new matter added to existing law.

[Brackets] indicate matter stricken from existing law.

1 [for the condition and size] TO MAINTAIN THE HEALTHY WEIGHT AND OVERALL HEALTH AND
2 WELL-BEING of the animal.

4 SECTION 2. *And be it further enacted*, That this Ordinance shall take effect 45 days from
5 the date it becomes law.


