1	AN EMERGENCY ORDINANCE concerning: Current Expense Budget - Transfer of
2	Appropriation - Chief Administrative Officer - Contingency - Management and
3	Control

5	FOR the purpose of transferring the appropriation of funds from the Contingency
6	Account of the Chief Administrative Officer to the Management and Control Account
7	of the Chief Administrative Officer to provide grants in accordance with the
8	recommendations of the Video Lottery Facility Local Development Council; and
9	making this Ordinance an emergency measure.

11	BY amending: Current Expense Budget

13	WHEREAS, pursuant to §§ 9-1A-27 and 9-1A-31 of the State Government
14	Article of the Maryland State Code, the County receives local impact grants from
15	the proceeds of video lottery terminals at video lottery facilities in the State; and
16	WHEREAS, for the fiscal year ending June 30, 2013, a portion of those local
17 18	impact grants are recognized in and appropriated through the Chief
19	Administrative Officer, Contingency Account; and
20	Administrative Officer, Contingency Account, and
21	WHEREAS, in accordance with § 9-1A-31, the County established the Video
22	Lottery Facility Local Development Council, which advises the County on the
23	impact of the facility on, the needs of, and the priorities of the communities in
24	immediate proximity to the video lottery terminal facility; and

26	WHEREAS, the Video Lottery Facility Local Development Council has made

1 recommendations for community grants in the total amount of \$100,000 to be paid out of the local impact grants for the fiscal year ending June 30, 2013; and 2 3 4 WHEREAS, the County Executive has approved the recommendations of the Video Lottery Facility Local Development Council; and 5 6 7 WHEREAS, under § 712 of the Charter, upon recommendation of the County Executive, the County Council may make supplementary appropriations from 8 contingent funds, provided that the Controller shall first certify in writing that 9 10 such funds are available for such appropriation; and 11 WHEREAS, the County Executive has made a recommendation that funds from 12 the appropriation to Chief Administrative Officer, Contingency, be transferred to 13 Chief Administrative Officer, Management & Control; and 14 15 WHEREAS, the Controller has certified in writing that such funds are available 16 17 for appropriation; now, therefore 18 SECTION 1. Be it enacted by the County Council of Anne Arundel County, 19 Maryland. That the Current Expense Budget for the fiscal year ending June 30, 2013, is 20 hereby amended by transferring the appropriation of funds from: 21 22 23 Chief Administrative Officer – General Fund Appropriation \$100,000 Contingency – Grants, Contributions & Other 24 25 26 to: Chief Administrative Officer – General Fund Appropriation 27 Management & Control – Grants Contributions & Other \$ 100,000 28 29 SECTION 2. And be it further enacted, That this Ordinance is hereby declared to be 30 an emergency ordinance and necessary for the immediate preservation of the public 31 peace, health, safety, welfare, and property, and being passed by the affirmative vote of 32 33 five members of the County Council, the same shall take effect from the date it becomes law. 34 READ AND PASSED this 20th day of May, 2013 By Order: Elizabeth E.
