A BILL ENTITLED

1 AN ORDINANCE concerning: Redistricting

2
3 FOR the purpose of repealing Bill No. 14-13, which revised the councilmanic districts,
4 and amending the councilmanic districts as revised in Bill No. 14-13.

5
6 WHEREAS, pursuant to the recommendations of the Charter Revision
7 Commission, the County Council, in Bill No. 14-13, corrected population
8 imbalances which became evident in the 2010 census; and

9
10 WHEREAS, the boundary line between the first and fourth councilmanic districts
11 in the area of River Bend at Russett in District Four runs through a portion of the
12 neighborhood of River Bend; and

13
14 WHEREAS, the boundary line between the fourth and sixth councilmanic
15 districts in the area between Fairfield Loop Road and Generals Highway in
16 District Four incorrectly moved the neighborhood of Fairfield to District Six; and

17
18 WHEREAS the County Council is authorized by Section 207 of the Charter to
19 revise, amend or reconstitute councilmanic districts by ordinance adopted by not
20 less than five of its members; and

21
22 WHEREAS, The County Council finds that this Ordinance, which amends the
23 councilmanic districts adopted in Bill 14-13, will cause the neighborhoods of
24 River Bend at Russett and Fairfield in District 4 to remain intact and consistent
25 with their historical boundaries; now, therefore,

27 SECTION 1. *Be it enacted by the County Council of Anne Arundel County,*
28 *Maryland,* That Bill No. 14-13 (Laws of Anne Arundel County 2013) is hereby repealed.

1 SECTION 2. *And be it further enacted*, That the boundaries of each of the seven
2 councilmanic districts are defined as follows and are further described in the list of
3 census blocks attached hereto as Exhibit A.

19 Northwest along Annapolis Rd. to Midway Branch Tributary,
20 Southwest along Midway Branch Tributary to Fort George G. Meade Military
21 Reservation boundary,
22 Southwest along the Fort George G. Meade Military Reservation boundary to Savage Rd.
23 and Rte. 32,
24 Southeast along Rte. 32 and west to the Little Patuxent River following Census Block
25 240037515002006,
26 Northwest along the Little Patuxent River
27 to the Anne Arundel County boundary with Howard County,
28 Northeast to County Boundary with City of Baltimore,
29 Southeast to the Patapsco River,
30 South to Curtis Bay,
31 West to starting point.

31 Following the South River Shoreline south to the Chesapeake Bay,
32 South along the western shore of the Chesapeake Bay to Walnut Ave and Beach Ave and
33 the County boundary with Calvert County,
34 Following the County Boundary with Calvert County to the west and north to Lyons
35 Creek,
36 Following Lyons Creek to the west to the eastern shore of the Patuxent River,
37 North along the eastern shore of the Patuxent River and the county boundary with Prince
38 George's County to Rt 3 Crain Highway,
39 Northeast following the centerline of Crain Highway to Crain Highway and Johns
40 Hopkins Rd.,

1 SECTION 3. *And be it further enacted*, That this Ordinance, being enacted by the
2 affirmative vote of five members of the County Council and being exempt from
3 Executive veto, shall take effect on the date of enactment.
