## A BILL ENTITLED

## AN ORDINANCE concerning: Redistricting

FOR the purpose of repealing Bill No. 14-13, which revised the councilmanic districts, and amending the councilmanic districts as revised in Bill No. 14-13.

WHEREAS, pursuant to the recommendations of the Charter Revision Commission, the County Council, in Bill No. 14-13, corrected population imbalances which became evident in the 2010 census; and

WHEREAS, the boundary line between the first and fourth councilmanic districts in the area of River Bend at Russett in District Four runs through a portion of the neighborhood of River Bend; and

WHEREAS, the boundary line between the fourth and sixth councilmanic districts in the area between Fairfield Loop Road and Generals Highway in District Four incorrectly moved the neighborhood of Fairfield to District Six; and

WHEREAS the County Council is authorized by Section 207 of the Charter to revise, amend or reconstitute councilmanic districts by ordinance adopted by not less than five of its members; and

WHEREAS, The County Council finds that this Ordinance, which amends the councilmanic districts adopted in Bill 14-13, will cause the neighborhoods of River Bend at Russett and Fairfield in District 4 to remain intact and consistent with their historical boundaries; now, therefore,

SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland, That Bill No. 14-13 (Laws of Anne Arundel County 2013) is hereby repealed.

SECTION 2. And be it further enacted, That the boundaries of each of the seven councilmanic districts are defined as follows and are further described in the list of census blocks attached hereto as Exhibit A.

## First Councilmanic District:

Southeast to the Chesapeake Bay,
Continuing along the Western Shore of the Chesapeake Bay,
Northwest along the north shore of the South River and its tributaries to the headwaters of the South River and Johns Hopkins Rd.,
Northeast along Johns Hopkins Rd. to Johns Hopkins Rd. and Saint Stephens Church Rd.,
South to Saint Stephens Church Rd. and Saint Stephens Woods Dr., East to Bacon Ridge Branch Tributary,
Following Bacon Ridge Branch Tributary to the northern boundary of the Maryland Environmental Trust Property,
East along the northern boundary of the Maryland Environmental Trust Property to I97, Crossing I-97 and following to the north boundary of Crownsville Hospital Property (owned by the State of Maryland) and Community Pl. to Fairfield Loop Rd. and Community Pl.,
Southeast along Fairfield Loop Rd. to Crownsville Rd. and Fairfield Loop Rd.,
North along Crownsville Rd. to Generals Highway and Crownsville Rd.,
North along Generals Highway to Herald Harbor Rd. and Generals Highway,

## Seventh Councilmanic District:

Including Turkey Point Island and Little Island, Flat Island, Big Island, and High Island.
Starting at $76^{\circ} 33^{\prime} 24.409$ "W $38^{\circ} 56^{\prime} 55.329$ " N at Solomon’s Island Rd. and the south shore of the South River,
Following the South River Shoreline south to the Chesapeake Bay,
South along the western shore of the Chesapeake Bay to Walnut Ave and Beach Ave and the County boundary with Calvert County,
Following the County Boundary with Calvert County to the west and north to Lyons Creek,
Following Lyons Creek to the west to the eastern shore of the Patuxent River,
North along the eastern shore of the Patuxent River and the county boundary with Prince George’s County to Rt 3 Crain Highway,
Northeast following the centerline of Crain Highway to Crain Highway and Johns Hopkins Rd.,
Southeast along Johns Hopkins Rd. to Johns Hopkins Rd. and Riedel Rd.,
South along Riedel Rd. to Farmingham Ln and Riedel Rd. and Johns Hopkins Rd.,
East along Johns Hopkins Rd. to Johns Hopkins and the Headwaters of the South River 1,500 Feet East of the Johns Hopkins Rd. and Underwood Rd.,
