17	4-11-101. Current expense budget - Long-term contracts and personnel summaries.

19	(b) Departmental personnel summaries. In addition to other material and information
20	required by the Charter or other law, the proposed current expense budget for each fiscal year
21	shall list detailed departmental personnel summaries that include the number of employees
22	by position title and classification; the pay grade for each position; the number of positions
23	requested in the current year's fiscal budget by position title and classification; the number of

positions approved in the current year's fiscal budget by position title and classification; and the number of positions requested in the upcoming fiscal year's budget by position title and classification. ONCE THE PROPOSED COUNTY BUDGET FOR THE UPCOMING FISCAL YEAR HAS BEEN SUBMITTED BY THE COUNTY EXECUTIVE TO THE COUNTY COUNCIL AS REQUIRED BY § 706 OF THE CHARTER, A DEPARTMENTAL PERSONNEL SUMMARY SHALL BE REVISED ONLY BY AN AMENDMENT TO THE BUDGET THAT IS PRESENTED TO AND ADOPTED BY THE COUNTY COUNCIL.
