4	WHEREAS, Section 311 of the County Charter provides that the County Council
5	shall have the power to implement the provisions of Section 311 and to assign
6	additional functions, duties and personnel to the County Auditor not inconsistent
7	with those duties provided in Section 311; and

9	WHEREAS, for more than four decades, the County Auditor has provided a letter
10	to the County Council in advance of each public hearing addressing the fiscal and
11	public policy implications of the proposed ordinances and resolutions to be heard
12	at the public hearing; and

14	WHEREAS, for more than three decades, the County Auditor has ensured Special
15	Community Benefit Districts meet the financial reporting requirements of Section
16	16-308 of the Annotated Code of Maryland, Local Government Article; and

18	WHEREAS, the County Council, by this Resolution, recognizes these long-
19	standing duties of the County Auditor as necessary and consistent with Section
20	311 of the County Charter; and
