4	FOR the purpose of transferring an appropriation of funds from the Chief Administrative
5	Office Contingency Account to the Department of Public Works for snow removal; and
6	making this Ordinance an emergency measure.

10	WHEREAS, under Section 711(a) of the Charter, upon recommendation of the
11	County Executive, the County Council may transfer funds between offices,
12 13	departments, institutions, boards, commissions or other agencies of the County government and within the same fund of the Current Expense Budget; and

15	WHEREAS, under § 712 of the Charter, upon recommendation of the County
16	Executive, the County Council may make supplementary appropriations from
17	contingent funds, provided that the Controller shall first certify in writing that such

21	appropriation to the Chief Administrative Office, Contingency, be transferred to the

Be it enacted by the County Council of Anne Arundel County, Maryland, 2 That the Current Expense Budget for the fiscal year ending June 30, 2015, be and it is hereby amended by transferring from the below-listed department in the amount set forth: 3 4 5 Chief Administrative Office – General Fund Appropriation 6 Contingency 7 Grants, Contributions & Other \$ 7,800,000 8 9 to the below-listed department in the amount set forth: 10 11 Department of Public Works – General Fund Appropriation Bureau of Highways 12 Personal Services \$1,700,000 13 Contractual Services \$3,100,000 14 \$3,000,000 15 Supplies & Materials 16

SECTION 2. And be it further enacted, That this Ordinance is hereby declared to be an emergency ordinance and necessary for the immediate preservation of the public peace, health, safety, welfare, and property and being passed by the affirmative vote of five members of the County Council, the same shall take effect from the date it becomes law.
