1 RESOLUTION appointing a member to the Anne Arundel County Adult Public
2 Guardianship Review Board

4 WHEREAS, the Family Law Article, § 14-402, of the State Code requires that the
5 Anne Arundel Adult Public Guardianship Review Board consist of 11 members
6 appointed by the County Executive with the advice and consent of the County
7 Council; and

8
9 WHEREAS, the Family Law Article, § 14-402(a)(2), of the State Code requires that,
10 of the 11 members, one shall be a professional representative of a local department of
11 social services; one shall be a physician's assistant, nurse practitioner, or physician
12 who is not a psychiatrist; one shall be a psychiatrist; one shall be a representative of a
13 local commission on aging; one shall be a professional representative of a local
14 nonprofit social service organization; one shall be a lawyer; two shall be lay
15 individuals; one shall be a registered nurse; one shall be a professional in the field of
16 disabilities; and one shall be a person with a physical disability; and

18 WHEREAS, the Family Law Article, § 14-402(b), of the State Code provides that the
19 term of a member is three years, that at the end of a term, a member continues to
20 serve until a successor is appointed and qualifies, and that a member who is appointed
21 after a term has begun serves only for the rest of the term and until a successor is
22 appointed and qualifies; and

24 WHEREAS, the term of the physician's assistant, nurse practitioner, or physician who
25 is not a psychiatrist has expired; and

27 WHEREAS, the County Executive, subject to the advice and consent of the County
28 Council, has appointed Donna F. Parker, M.D., a physician who is not a psychiatrist,
29 to a term expiring August 31, 2019; and



31 WHEREAS, the County Council, after public hearing, finds that Donna F. Parker,
32 M.D., meet the eligibility requirements under the Family Law Article, § 14-402, of the
33 State Code and is qualified to serve on the Anne Arundel County Adult Public
34 Guardianship Review Board; now, therefore, be it

1 *Resolved by the County Council of Anne Arundel County, Maryland, That it hereby*
2 *approves the appointment of Donna F. Parker, M.D., a physician who is not a psychiatrist, to*
3 *serve as a member of the Anne Arundel County Adult Public Guardianship Review Board for*
4 *a term that expires on August 31, 2019; and be it further*

6 *Resolved, That a copy of this Resolution be sent to County Executive Steven R. Schuh;*
7 *appointee Donna F. Parker, M.D.; and Arlene Berlin, Director of Boards and Commissions.*
