1	RESOLUTION urging the Anne Arundel County Board of Education (the "School
2	Board") to adopt a policy which allows for the consideration of any individual student's need
3	for accommodation without infringing upon any constitutional and natural rights of other
4	students or parents of other students within the Anne Arundel County Public Schools
5	("AACPS").

7	WHEREAS, the purpose of government is to secure and protect God given rights;

10	WHEREAS, it is incumbent upon the School Board to follow all laws and
11	regulations concerning accommodation and non-discrimination; and

13	WHEREAS, the May 2016 U.S. Department of Education resource manual titled
14	Examples of Policies and Emerging Practices for Supporting Transgender Students
15	and the October 2015 Maryland State Department of Education manual titled
16	Providing Safe Spaces for Transgender and Gender Non-Conforming Youth:
17	Guidelines for Gender Identity Non-Discrimination are not laws or regulations, but
18 19	rather guidelines that are neither mandatory nor compulsory; and
20	WHEREAS the rights of all students within the AACDS and the second
21	WHEREAS, the rights of all students within the AACPS system must be protected during the consideration of an individual student's need for accommodation; and

23	WHEREAS, the County Council does not believe that government can effectively,
24	consistently and safely rely on determinations of gender which are based on

31	accommodate any student's interest in privacy through the creation of private bathrooms,
32	locker room areas, and other spaces for any student who voluntarily seeks additional privacy;

Resolved, That no effort should be made by any school personnel to compel any student to violate his or her conscience in any manner; and be it further
