Resolution No. 47-15

Introduced by Mr. Peroutka, Mr. Walker, Mr. Grasso and Mr. Fink

By the County Council, September 8, 2015

1 Resolution providing notice of intent to decrease participation and phase-out of
2 funding Charitable Organizations through the Government Grant Program in the Anne
3 Arundel County Expense Budget through the Chief Administrative Office.

5 WHEREAS, the County Council is presented each year with a Current Expense
6 Budget for the Chief Administrative Office that includes a list of charitable
7 organizations who have applied for and qualified for receipt of Government
8 Grants provided by the County; and

10 WHEREAS, the County Council acknowledges that the Government Grant
11 Program of the Chief Administrative Office has become an important source of
12 revenue for certain charitable organizations; and

14 WHEREAS, the County Council recognizes that the Government Grant Program
15 has, in providing the grants, moved forward with funding programs that are
16 separate from the key functions of government and better suited to be funded
17 and managed through private contributions rather than taxpayer dollars; and

18
19 WHEREAS, the County Council provides notice by way of this Resolution that,
20 in Fiscal Year 2017, organizations that have not received Government Grants
21 from Anne Arundel County in Fiscal Year 2016 will not receive funds from the
22 Government Grant Program of the Chief Administrative Office in future years;

25 WHEREAS, the County Council further provides that those organizations
26 receiving government grants in Fiscal Year 2016 should expect a 50% reduction
27 in grant funds in Fiscal Year 2017; and

29 WHEREAS, the County Council further states that, beginning in Fiscal Year
30 2018, the Government Grant Program of the Chief Administrative Office will
31 not receive funding from the County Council in the Fiscal Year 2018 Expense
32 Budget for Anne Arundel County or any fiscal year thereafter; now, therefore,
33 be it

35 *Resolved by the County Council of Anne Arundel County, Maryland,* That the
36 County Council provides notice of its intent to decrease participation and phase-out
37 funding of charitable organizations through the Government Grant Program in the Anne
38 Arundel County Expense Budget through the Chief Administrative Office.

1 *Be it further resolved*, That the County Council further recommends to the County
2 Administration that notice of this Resolution be provided within 30 days of the approval
3 of this Resolution to all recipients of grants through the Government Grant Program.

5 *Be it further resolved*, That a copy of this Resolution be forwarded to County
6 Executive Steven R. Schuh.


