20	(A) Definition. IN THIS SECTION, "PUBLIC-PRIVATE PARTNERSHIP" MEANS A
21	CONTRACT IN WHICH THE SKILLS AND ASSETS OF THE PUBLIC SECTOR AND THE PRIVATE
22	SECTOR ARE SHARED IN DELIVERING A SERVICE OR FACILITY FOR THE USE OF THE
23 24	GENERAL PUBLIC AND EACH SECTOR SHARES IN THE POTENTIAL RISKS AND REWARDS.
25	(B) Requirement. THE COUNTY SHALL MAXIMIZE OPPORTUNITIES FOR PUBLIC-
26 27	PRIVATE PARTNERSHIPS WHEN IT IS FEASIBLE TO DO SO AND IS IN THE BEST INTEREST OF THE COUNTY.
