18 Unless defined in this article, the Natural Resources Article of the State Code, or  
19 COMAR, words defined elsewhere in this Code apply in this article. The following words

22 (93) “Private club” means [a facility that is used] AN  
23 ESTABLISHMENT THAT PROVIDES FACILITIES TO MEMBERS for social or recreational  
24 purposes [and that], IS NOT OPEN TO THE PUBLIC, is not operated [primarily] for profit or


1 commercial purposes, AND IS EXEMPT FROM TAXATION UNDER § 501(C) OF THE INTERNAL
