2	Arundel County Retiree Health Benefits Trust
3 4	WHEDEAS & 6.5 104 of the Arms Arms of Country Code (2005
5	WHEREAS, § 6-5-104 of the Anne Arundel County Code (2005, as amended) provides that there is a Board of Trustees for the Anne Arundel County Retiree
6	Health Benefits Trust that shall consist of at least eight Trustees; and
7	reduction Benefits Trust that shall consist of at least eight Trustees, and
8	WHEREAS, § 6-5-104(b) of the Anne Arundel County Code (2005, as amended)
9	provides that four Trustees shall be appointed by the County Executive and
10	confirmed by resolution of the County Council; and

12	WHEREAS, by Resolution No. 28-15, Dennis P. Howell, a retiree who is a
13	member of one of the uniformed public safety unions and who was nominated by
14	a majority of the presidents of the County uniformed public safety unions, was
15	appointed as a Trustee to serve an initial term of two years beginning July 1, 2015
16	and ending July 1, 2017; and

18	WHEREAS, Dennis P. Howell has resigned as a Trustee, creating a vacancy on
19	the Board of Trustees for the Anne Arundel County Retiree Health Benefits Trust
20	for an active employee who is a member of one of the uniformed public safety
21	unions or a retiree who retired as a member of the one of the uniformed public
22	safety unions, and who is nominated by a majority of the presidents of the County
23 24	uniformed public safety unions; and
25	WHEREAS, the County Executive, subject to confirmation by the County
26	Council, has appointed O'Brien Atkinson, IV, an active employee who is a
27	member of one of the uniformed public safety unions and who was nominated by
28	a majority of the presidents of the County uniformed public safety unions, to fill
29	the vacancy and serve the remainder of the term of Dennis P. Howell; and

31	WHEREAS, the County Executive, subject to confirmation by the County
32	Council, has appointed O'Brien Atkinson, IV to serve the remainder of the term
33	of Dennis P. Howell, beginning on the effective date of this Resolution and
34	ending July 1, 2017; and

WHEREAS, the County Council, after public hearing, finds that O'Brien
