4	FOR the purpose of allowing commercial telecommunication facilities that are antennas to					
5	be attached to structures under certain conditions in mixed used districts; and generally					
6	relating to commercial telecommunication facilities.

8	WHEREAS, many citizens of Anne Arundel County rely on telecommunication					
9	facilities in their daily business, social, and family lives, resulting in an ever-					
10	increasing demand for telecommunication services in the County; and

13	improvements to telecommunication facilities so as to provide quality public safety
