A BILL ENTITLED

AN ORDINANCE concerning: Severn Grove Special Community Benefit District -1 Approval of Loan and Assignment Agreement 2 3 FOR the purpose of obligating the County to levy the special tax known as the special 4 community benefit assessment on the Severn Grove Special Community Benefit 5 District in an amount sufficient to repay a loan from Severn Savings Bank to the 6 Severn Grove Improvement Association, Inc. in each of ten (10) fiscal years during 7 the term of the loan. 8 9 WHEREAS, the Severn Grove Special Community Benefit District has been duly 10 formed and created, pursuant to procedures set forth in Anne Arundel County 11 Code, Article 4, Title 7; and 12 13 WHEREAS, pursuant to § 4-7-204(bbb) of the Anne Arundel County Code, the 14 purposes of the Severn Grove Special Community Benefit District are 15 "maintaining and improving all real and personal property owned by the Severn 16 Grove Improvement Association, Inc.; providing community recreational 17 activities; and paying all costs associated with these purposes, including office 18 expenses, postage and mailing, the repayment of any loans, insurance costs, legal 19 and audit fees, administrative fees to the County, and bonding expenses"; and 20 21 WHEREAS, the Severn Grove Improvement Association, Inc. (the "Association") 22 is the civic or community association that meets the requirements of § 4-7-101(d) 23 that administers the District; and 24

WHEREAS, the Association is entering into a loan agreement with Severn Savings Bank in the amount of \$75,000, with a term of ten (10) years, to be used

for capital improvements to the Severn Grove Improvement Association, Inc.'s facilities (the "Loan"); and

WHEREAS, to enable the Association to obtain the Loan from Severn Savings Bank by providing a source of funds for repayment of the Loan, the County is undertaking the obligation set forth in this Ordinance; now, therefore,

SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland, That the County shall be obligated to levy the special tax known as the special community benefit assessment on the Severn Grove Special Community Benefit District in an amount sufficient to repay the Loan from Severn Savings Bank to Severn Grove Improvement Association, Inc. in each of up to ten (10) fiscal years during the term of the Loan, beginning in the County's Fiscal Year 2014.

SECTION 2. And be it further enacted, That the County undertakes no obligation with regard to the Loan except as expressly described in this Ordinance, is neither a co-obligor nor guarantor of the Loan, and does not commit the full faith and credit of the County to repayment of the Loan.

SECTION 3. And be it further enacted, That the County Executive is hereby authorized to enter into such other and further agreements with the Association and Severn Savings Bank as are necessary to disburse directly to Severn Savings Bank such amounts of the special community benefit assessment levied on the Severn Grove Special Community Benefit District as are collected by the County and are necessary to repay the Loan consistent with this Ordinance.

SECTION 4. And be it further enacted, That this Ordinance shall take effect 45 days from the date it becomes law.
