18	The permitted, conditional, and special exception uses allowed in Open Space Districts

20	(OS) and in the Open Space Conservation Overlay (OS-C) are listed in the chart in this
21	section using the following key: P = permitted use; C = conditional use; SE = special
22	exception use. Except as provided otherwise in this article, uses and structures customarily
23	accessory to the listed uses also are allowed.
