A BILL ENTITLED

AN ORDINANCE concerning: Tax Levies - Special Community Benefit Districts, Shore

Erosion Control Districts, and Waterways Improvement Districts

FOR the purpose of levying and imposing the tax rates for special community benefit districts, shore erosion control districts, and waterways improvement districts required by the County Budget for Fiscal Year 2016.

WHEREAS, Section 710(c) of the Charter provides that, when the County Budget shall have been finally adopted in the Annual Budget and Appropriation Ordinance, the County Council shall thereupon levy and cause to be raised the amount of taxes required by the Budget; and

WHEREAS, the County Budget has finally been adopted, and the County Council has determined that taxes in the following amounts are required to fund the appropriations for the following districts; now, therefore,

SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland, That a special community benefit district tax, a shore erosion control district tax, and a waterways improvement district tax for the taxable year beginning July 1, 2015, and ending on June 30, 2016, are hereby levied and imposed on all of the assessable property in the special community benefit districts, shore erosion control districts, and waterways improvement districts named; and that the rate of taxation for such purposes is hereby fixed as set forth in each special community benefit district (SCBD), each shore erosion control district (SECD), and each waterways improvement district (WID) named as follows:
