

20 (b) **Administrative appeal.** A property owner may appeal a stormwater remediation
21 fee to the Department. An appeal shall be submitted on or before [August 15]
22 SEPTEMBER 30 in order to receive a correction of the stormwater remediation fee for the
23 CURRENT BILLING [succeeding taxable] year [except that nonprofit organizations or a
24 property owner of a farm appealing a fee levied in fiscal year 2014 shall submit their
25 appeal on or before December 1].

EXPLANATION: CAPITALS indicate new matter added to existing law.
[Brackets] indicate matter stricken from existing law.

1 SECTION 2. *And be it further enacted*, That this Ordinance shall take effect 45 days
2 from the date it becomes law.






