1	AN ORDINANCE concerning: Zoning - Requirements for Conditional Uses -
2	Automobile, Truck, and Recreational Vehicle Sales

4	FOR the purpose of amending the conditional use requirements to allow automobile, truck
5	and recreational vehicle sales on lots of at least one acre when vehicular access is
6	provided to at least two arterial roads; exempting automobile, truck, and recreational
7	vehicles sales located on a lot or parcel of at least one acre from a certain storage
8	requirement; and generally relating to zoning.

(1) The facility shall be on a lot or parcel located within 300 feet of a lot or parcel where

(3) The lot or parcel on which the facility is located shall be within a priority funding

(4) The facility shall comply with the requirements of the County Landscape Manual.

(5) The facility shall be located on a lot or parcel of at least two acres, EXCEPT THAT A

(7) Except for vehicles displayed in a showroom AND FACILITIES ON A LOT OR PARCEL OF AT LEAST ONE ACRE WITH VEHICULAR ACCESS TO AT LEAST TWO ARTERIAL ROADS,

SECTION 2. And be it further enacted, That this Ordinance shall take effect 45 days

By Order:

at least 75% of the vehicles available for sale shall be parked behind the buildings

FACILITY MAY BE LOCATED ON A LOT OR PARCEL OF AT LEAST ONE ACRE IF VEHICULAR

(2) The facility shall have vehicular access to an arterial road.

ACCESS IS PROVIDED TO AT LEAST TWO ARTERIAL ROADS.

(6) The facility shall be served by public water and sewer.
