| 13 14 | WHEREAS, the fiscal year 2020 budget request for the South River Manor Special |
| 15 | Community Benefit District ("SCBD") was not submitted to the Office of the |
| 16 | Budget until April of 2019, and was not included in the fiscal year 2020 budget |

| 19 | WHEREAS, under Section 712 of the Charter, upon the recommendation of the |
| 20 | County Executive, the County Council may make supplementary appropriations |
| 21 | from revenues received from anticipated sources but in excess of budget estimates |

| 23 | current fiscal year, provided that the Controller shall first certify in writing that such |
| 24 | funds are available for appropriation; and |

| 27 | appropriation of certain funds, and the Controller has certified in writing that such |
| 28 | funds are available for appropriation; now, therefore, |

SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland, That the Current Expense Budget for the fiscal year ending June 30, 2020, is hereby amended by making supplementary appropriations from revenues received from sources not anticipated in the budget to the South River Manor SCBD in the amount of \$8,641.
