3 FOR the purpose of amending the date by which the County Council must levy the  
4 annual property tax; making this Ordinance an emergency measure; and generally  
5 relating to taxes

7 BY repealing and reenacting with amendments: § 4-1-102  
8 Anne Arundel County Code (2005, as amended)

10 SECTION 1. *Be it enacted by the County Council of Anne Arundel County,*  
11 *Maryland,* That Section(s) of the Anne Arundel County Code (2005, as amended) read as  
12 follows:

14 **ARTICLE 4. FINANCE, TAXATION AND BUDGET**

15  
16 **TITLE 1. REAL AND PERSONAL PROPERTY TAXES**

17  
18 **4-1-102. Date of levy.**

19  
20 The County Council shall levy property taxes ON OR before [June 1] ~~JUNE 15~~ JUNE 30  
21 each year.



23 SECTION 2. *And be it further enacted,* That this Ordinance is hereby declared to be  
24 an emergency ordinance and necessary for the immediate preservation of the public  
25 peace, health, safety, welfare, and property and being passed by the affirmative vote of  
26 five members of the County Council, shall take effect from the date it becomes law.






