11	SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland,
12	That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

14	ARTICLE 4. FINANCE, TAXATION, AND BUDGET

16	TITLE 7. SPECIAL COMMUNITY BENEFIT DISTRICTS, SHORE EROSION
17	CONTROL DISTRICTS, AND WATERWAYS IMPROVEMENT DISTRICTS

19	4-7-202. Procedure for establishment of district.
20	
21	(a) By County Council. The County Council may establish special community benefit
22	districts FOR RESIDENTIAL AND NON-RESIDENTIAL AREAS in the County, furnish and provide
23	special privileges or benefits to persons or property in the districts, and levy special taxes on

property in the districts receiving the special benefit to pay the costs of furnishing, providing, and maintaining the special privileges or benefits.
