A BILL ENTITLED

1 AN ORDINANCE concerning: Legislative Branch – Compensation

2  
3 FOR the purpose of setting the rate of compensation of members of the County Council  
4 by adopting certain recommendations of the Salary Standard Commission; and  
5 generally relating to the County Council

6  
7 By repealing and reenacting with amendments: § 2-2-101  
8 Anne Arundel County Code (2005, as amended)

9  
10 WHEREAS, the salaries for the County Council Chair, Vice Chair and Council  
11 member were last set by the County Council in 2002; and

12  
13 WHEREAS, the Anne Arundel County Salary Standard Commission has  
14 submitted a report recommending an increase in salary and other benefits for the  
15 members of the County Council for the Council term beginning in December  
16 2014; and

18 WHEREAS, the Anne Arundel County Council, in recognition of the  
19 recommendations of the Salary Standard Commission, is hereby adopting the  
20 recommendation for a change in salary within an amount suggested by the Salary  
21 Standard Commission, but not other recommended benefits considered to be  
22 compensation; now, therefore,

24 SECTION 1. *Be it enacted by the County Council of Anne Arundel County,*  
25 *Maryland,* That Section(s) of the Anne Arundel County Code (2005, as amended) read as  
26 follows:

5 **2-2-101. Compensation.**

6  
7       The salaries of the members of the County Council shall be as follows:

8  
9       (1) The Chair of the County Council is entitled to receive, while in that office, an  
10 annual salary [of \$40,500 for the entire term] AS FOLLOWS:

11  
12           (I) beginning the first Monday in December, [2002] 2014, \$41,715;

13  
14           (II) BEGINNING THE FIRST MONDAY IN DECEMBER, 2015; \$42,966;

15  
16           (III) BEGINNING THE FIRST MONDAY IN DECEMBER, 2016; \$44,255; AND

17  
18           (IV) BEGINNING THE FIRST MONDAY IN DECEMBER, 2017 \$45,583.

19  
20       (2) The Vice Chair of the County Council is entitled to receive, while in that office,  
21 an annual salary [of \$37,000 for the entire term] AS FOLLOWS:

22  
23           (I) beginning the first Monday in December, [2002] 2014, \$38,100;

24  
25           (II) BEGINNING THE FIRST MONDAY IN DECEMBER, 2015; \$39,253;

26  
27           (III) BEGINNING THE FIRST MONDAY IN DECEMBER, 2016; \$40,430; AND

28  
29           (IV) BEGINNING THE FIRST MONDAY IN DECEMBER, 2017 \$41,643.

30  
31       (3) Each other member of the County Council is entitled to receive, while in that  
32 office, an annual salary [of \$36,000 for the entire term] AS FOLLOWS:

34           (I) beginning the first Monday in December, [2002] 2014, \$37,080;

35  
36           (II) BEGINNING THE FIRST MONDAY IN DECEMBER, 2015; \$38,192;

37  
38           (III) BEGINNING THE FIRST MONDAY IN DECEMBER, 2016; \$39,338; AND

39  
40           (IV) BEGINNING THE FIRST MONDAY IN DECEMBER, 2017 \$40,518.

42       SECTION 2. *And be it further enacted*, That this Ordinance shall take effect 45 days  
43 from the date it becomes law.
