1	AN EMERGENCY ORDINANCE concerning: Capital Budget and Program and Capital
2	Project Bonds Ordinance - Reforest Prgm-Land Acquisition Capital Project - Additional
3	Appropriation – \$1,689,000

5	FOR the purpose of amending the Capital Budget by making an additional appropriation of
6	funds from the Reforestation Fund to the Reforest Prgm-Land Acquisition capital project,
7	Project No. C531200; amending the Capital Program and Capital Projects Bond
8 -	Ordinance; and making this ordinance an emergency measure.

10	BY amending: Capital Budget

14	WHEREAS, the Reforest Prgm-Land Acquisition capital project, Project No.
15	C531200, has an existing appropriation in the Capital Budget for the fiscal year
16	ending June 30, 2014, and additional funds in excess of budget estimates in the
17	amount of \$1,689,000 are needed during the current fiscal year for expenditure
18	consistent with the description of the project; and
19	WHEREAS, funds in excess of \$1,689,000 have been appropriated in the Current
20	Expense Budget for the Reforestation Fund for the current fiscal year, and
21 22	Expense Budget for the Reforestation rank for the outrent used year, and
22 23	WHEREAS, pursuant to Sections 712 and 716 of the Charter, upon recommendation
23 24	of the County Executive, the County Council may make supplementary appropriations
2 4 25	to the Capital Budget from revenues received from anticipated sources but in excess

of budget estimates for the current fiscal year, and 1 2 WHEREAS, Section 716 of the Charter authorizes the County Council, upon request 3 of the County Executive and by the affirmative vote of five members of the County 4 Council, to amend the capital budget; and 5 6 WHEREAS, the County Executive has recommended a supplementary appropriation 7 of funds in the amount of \$1,689,000 to the Reforest Prgm-Land Acquisition capital 8 project, Project No. C531200, from the Reforestation Fund, revenues received from 9 anticipated sources but in excess of budget estimates for the current fiscal year; and 10 11 WHEREAS, in accordance with Section 716 of the Charter, the Planning Advisory 12 Board has recommended this amendment to the Capital Budget; and 13 14 WHEREAS, the Controller has certified in writing that the funds are available for 15 transfer; and 16 17 WHEREAS, Section 307(i) of the Charter authorizes the County Council to increase 18 the funding for capital projects by emergency ordinance so long as the increases are 19 required solely to meet cost escalation and do not affect the scope of the project, and 20 the County Council has determined these criteria to be met; now, therefore, 21 22 SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland, 23 That the Capital Budget for the fiscal year ending June 30, 2014, is hereby amended by 24 making an additional appropriation in the amount of \$1,689,000 from the Reforestation Fund 25 to the Reforest Prgm-Land Acquisition capital project, Project No. C531200. 26 27 SECTION 2. And be it further enacted, That the Capital Program and Capital Projects 28 Bond Ordinance are hereby amended in accordance with the provisions of this Ordinance. 29 30 SECTION 3. And be it further enacted, That this Ordinance is hereby declared to be an 31 emergency ordinance and necessary for the immediate preservation of the public peace, 32 health, safety, welfare, and property and being passed by the affirmative vote of five members 33 of the County Council, the same shall take effect from the date it becomes law. 34 READ AND PASSED this 18th day of November, 2013 E.
