## A BILL ENTITLED

1	AN EMERGENCY ORDINANCE concerning: Capital Budget and Program - Harmans
2	Road Culvert Rehab- Fund Transfer

4	FOR the purpose of amending the Capital Budget by transferring an appropriation of
5	funds from the New Cut Rd Cul Rep capital project to the Harmans Road Culvert
6	Rehab capital project; amending the Capital Program and Capital Projects Bond
7	Ordinance; and making this Ordinance an emergency measure.

9	BY amending: Capital Budget

13	WHEREAS, the Harmans Road Culvert Rehab capital project, Project No.
14	D515600, has an existing appropriation; and
15	
16	WHEREAS, Section 716 of the Charter authorizes the County Council, upon
17	request of the County Executive and by the affirmative vote of five members of the
18	County Council, to amend the capital budget; and
19	
20	WHEREAS, Section 711(b) of the Charter authorizes the County Council, upon
21	request of the County Executive, to transfer appropriations between capital
22	projects in the Capital Budget; and

1 WHEREAS, the County Executive is requesting that \$490,000 be transferred from 2 the New Cut Rd Cul Rep capital project, Project No. D480900, to the Harmans Road Culvert Rehab capital project, Project No. D515600; and 3 4 5 WHEREAS, the Planning Advisory Board has recommended these amendments to the Capital Budget in accordance with Section 716 of the Charter; and 6 7 WHEREAS, the Controller has certified in writing that such funds are available for 8 9 appropriation; and 10 11 WHEREAS, Section 307(i) of the Charter authorizes the County Council to increase the funding for capital projects by emergency ordinance so long as the 12 increases are required solely to meet cost escalation and do not affect the scope of 13 the project, and the County Council has determined these criteria to be met; now 14 15 therefore, 16 17 SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland, that the Capital Budget for the fiscal year ending June 30, 2015, is hereby 18 19 amended by transferring appropriations in the amount of \$490,000 from the New Cut Rd Cul Rep capital project, Project No. D480900 (General County Bonds), to the Harmans 20 Road Culvert Rehab capital project, Project No. D515600 (General County Bonds). 21 22 23 SECTION 2. And be it further enacted, That the Capital Program and Capital Projects Bond Ordinance for the fiscal year ending June 30, 2015, are hereby amended in 24 accordance with the provisions of this Ordinance. 25 26 SECTION 3. And be it further enacted, That this Ordinance is hereby declared to be 27 28 an emergency ordinance and necessary for the immediate preservation of the public peace. health, safety, welfare, and property, and being passed by the affirmative vote of five 29 members of the County Council, the same shall take effect from the date it becomes law. 30 READ AND PASSED this 20th day of January, 2015 By Order: Elizabeth E.
