10	WHEREAS, under Section 712 of the Charter, upon the recommendation of the
11	County Executive, the County Council may make additional appropriations from
12	revenues received from sources not anticipated in the budget or from revenues
13	received from anticipated sources but in excess of budget estimates for the current
14	fiscal year, provided that the Controller shall first certify in writing that such
15	funds are available for appropriation; and

17	WHEREAS, the County Executive has recommended supplementary
18	appropriations from revenues received from anticipated sources but in excess of
19	budget estimates; and

21	WHEREAS, the Controller has certified in writing that such funds are available
22	for appropriation; now, therefore,

24	SECTION 1. Be it enacted by the County Council of Anne Arundel County, That the
25	Current Expense Budget for the fiscal year ending June 30, 2017, be and it is hereby

amended by making supplementary appropriations from revenues received from

anticipated sources but in excess of budget estimates as follows:
