A BILL ENTITLED

1 AN ORDINANCE concerning: Current Expense Budget – Supplementary Appropriations  
2 – Video Lottery Facility Local Impact Grant Special Revenue Fund  
3

4 FOR the purpose of making supplementary appropriations from unanticipated revenues to  
5 the Video Lottery Facility Local Impact Grant Special Revenue Fund for the fiscal  
6 year ending June 30, 2017.

8 BY amending: Current Expense Budget  
9

10 WHEREAS, under Section 712 of the Charter, upon the recommendation of the  
11 County Executive, the County Council may make additional appropriations from  
12 revenues received from sources not anticipated in the budget or from revenues  
13 received from anticipated sources but in excess of budget estimates for the current  
14 fiscal year, provided that the Controller shall first certify in writing that such  
15 funds are available for appropriation; and

17 WHEREAS, the County Executive has recommended supplementary  
18 appropriations from revenues received from anticipated sources but in excess of  
19 budget estimates; and

21 WHEREAS, the Controller has certified in writing that such funds are available  
22 for appropriation; now, therefore,

24 SECTION 1. *Be it enacted by the County Council of Anne Arundel County*, That the  
25 Current Expense Budget for the fiscal year ending June 30, 2017, be and it is hereby  
26 amended by making supplementary appropriations from revenues received from  
27 anticipated sources but in excess of budget estimates as follows:

1 Unappropriated fund balance of the  
 2 Video Lottery Facility Local Impact Grant Special Revenue Fund \$ 550,000

 4 and by adding such funds to the below-listed fund, in the respective amounts set forth:

 6 Video Lottery Facility Local Impact Grant Special Revenue Fund

 8 VLT Community Grants  
 9 Grants, Contributions & Other \$ 80,000

 11 Office of Finance (Non-Departmental)  
 12 Video Lottery Impact Aid  
 13 Grants, Contributions & Other \$ 470,000


15 SECTION 2. *And be it further enacted*, That this Ordinance shall take effect 45 days




