time that a fee waiver applies shall be determined by the Chief or the Chief's designee and may be initiated or suspended at any time. THE CHIEF OR THE CHIEF'S DESIGNEE SHALL WAIVE ADOPTION FEES, EXCEPT ANY CHARGE INCURRED FOR SPAYING OR NEUTERING OF THE ANIMAL PURSUANT TO SUBSECTIONS (C) AND (D), FOR THE PLACEMENT OF AN ANIMAL WITH A PRIVATE, NONPROFIT ANIMAL SHELTER OR RESCUE ORGANIZATION.
