1 AN ORDINANCE concerning: Animal Control – Adopted Animals – Waiver of Fees

3 FOR the purpose of waiving ~~certain~~ adoption fees for placement of an animal with a
4 private nonprofit animal shelter or rescue organization; and generally relating to
5 animal control.

7 BY repealing and reenacting with amendments: § 12-4-912(e)

10 SECTION 1. *Be it enacted by the County Council of Anne Arundel County,*
11 *Maryland,* that Sections(s) of the Anne Arundel County Code (2005, as amended) read as

14 ARTICLE 12. PUBLIC SAFETY
15 TITLE 4. ANIMAL CONTROL

17 12-4-912. Adopted animals – spaying or neutering fees; waiver of fees.

19 (e) Waiver of adoption fees. At the discretion of the Chief or the Chief's designee,
20 Animal Control may waive some or all adoption fees, including, but not limited to, any
21 fees listed in subsection (b)(4) and any expenses included in subsection (d). The length of


1 time that a fee waiver applies shall be determined by the Chief or the Chief's designee
2 and may be initiated or suspended at any time. THE CHIEF OR THE CHIEF'S DESIGNEE
3 SHALL WAIVE ADOPTION FEES, EXCEPT ANY CHARGE INCURRED FOR SPAYING OR
4 NEUTERING OF THE ANIMAL PURSUANT TO SUBSECTIONS (C) AND (D), FOR THE
5 PLACEMENT OF AN ANIMAL WITH A PRIVATE, NONPROFIT ANIMAL SHELTER OR RESCUE
6 ORGANIZATION.

8 SECTION 2. *And be it further enacted*, That this Ordinance shall take effect 45 days
9 from the date it becomes law.




