3 4	FOR the purpose of adding Juneteenth as a recognized holiday for eligible County
5 6 7	employees; increasing the amount of annual leave for certain classified employees required to work on holidays; and generally relating to personnel.

18 19	SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland, That § 6-1-301(a)(6) through (13), respectively, of the Anne Arundel County Code (2005)
20 21	as amended) is hereby renumbered to be § 6-1-301(a)(7) through (14), respectively.
22 23	SECTION 2. And be it further enacted, That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

1 **ARTICLE 6. PERSONNEL** 2 TITLE 1. CLASSIFIED SERVICE 3 4 5 6-1-301. Holidays. 6 7 (a) Recognized holidays. Except as otherwise provided in this section, full-time 8 employees in the classified service are entitled to holiday leave for the following holidays: 9 10 *** 11 12 13 (6) JUNETEENTH (JUNE 19); 14 *** 15 16 (b) Classified employees who are required to work on holidays. Except as 17 otherwise provided in a memorandum of agreement negotiated and signed under Title 4 18 between the County and an exclusive representative, employees in the classified positions 19 20 identified by the Personnel Officer as regularly required to work on holidays shall receive [[15]] 16 additional days of annual leave each year instead of holidays. 21 22 SECTION 3. And be it further enacted, That this Ordinance shall take effect 45 days 23 from the date it becomes law. 24
