1 RESOLUTION amending Section 6-105 of the Rules of Procedure of the County  
2 Council

4 WHEREAS, pursuant to Section 208(g) of the Charter, the County Council is  
5 required to adopt rules of procedure; and

6  
7 WHEREAS, Section 1-103 of these Rules of Procedure provides that the County  
8 Council may amend the Rules by resolution provided the amendment is submitted  
9 in writing to the County Council at least seven days before the action on the  
10 resolution; now, therefore, be it

12 *Resolved by the County Council of Anne Arundel County, Maryland, That Section(s)*  
13 *of the Rules of Procedure of the County Council of Anne Arundel County (September*  
14 *2013) read as follows:*

16 **TITLE 6. MOTIONS**

18 **6-105. Motion for reconsideration.**

19  
20 (a) **Generally.** When a question has once been decided, a motion for reconsideration  
21 is in order if the bill, resolution, motion, or matter upon which the vote was taken is still  
22 in the possession of the County Council OR IS A RECONSIDERATION OF A CHARTER  
23 AMENDMENT VOTE PURSUANT TO SUBSECTION (B).

24  
25 (b) **Limitations.** A motion for reconsideration is not in order unless made on the  
26 same day on which the original vote was taken, or at the next legislative session of the  
27 County Council, EXCEPT THAT A MOTION TO RECONSIDER A VOTE ON A RESOLUTION TO  
28 AMEND THE CHARTER MAY BE MADE AT ANY TIME BEFORE THE CERTIFICATION DATE  
29 FOR THE QUESTION REQUIRED IN §7-103 OF THE ELECTION ARTICLE IN THE STATE CODE.

31 (c) **Person to make the motion.** The motion for reconsideration shall be made by a  
32 member who voted with the prevailing side on the original question. In the case of a tie  
33 vote, either side of the question may make a motion for reconsideration and it shall be  
34 reconsidered on the majority vote of all members present and voting.
