1 RESOLUTION approving appointments of Severn River Commission members

3 WHEREAS, the County Council of Anne Arundel County established the Severn
4 River Commission in Resolution No. 130-84, and reestablished the Commission
5 in Resolution No. 47-89; and

7 WHEREAS, Resolution No. 47-89 provides that, subject to confirmation by the
8 County Council, the County Executive shall appoint seven members to the Severn
9 River Commission, at least five of whom are residents of the Severn River
10 watershed; and

12 WHEREAS, Resolution No. 47-89 further provides that each member of the
13 Severn River Commission shall serve a term of three years from the date of
14 appointment; and

16 WHEREAS, the County Executive has appointed Charles R. Kreter and Sara G.
17 Phillips, who are residents of the Severn River Watershed, to serve on the Severn
18 River Commission for terms ending on January 31, 2018; Stephen B. McHale,
19 who is not a resident of the Severn River Watershed, to serve on the Severn River
20 Commission for a term ending on January 31, 2018; and Daniel J. Roche, who is
21 not a resident of the Severn River Watershed, to serve on the Severn River
22 Commission for the remainder of a term ending January 31, 2017; and

24 WHEREAS, the County Council, after a public hearing, finds that Charles R.
25 Kreter, Sara G. Phillips, Stephen B. McHale, and Daniel J. Roche meet the
26 eligibility requirements under Resolution No. 47-89, and are qualified to serve on
27 the Severn River Commission; now, therefore, be it

29 *Resolved by the County Council of Anne Arundel County, Maryland,* That it confirms
30 the appointment of Charles R. Kreter and Sara G. Phillips, who are residents of the
31 Severn River Watershed, to serve on the Severn River Commission for terms ending on
32 January 31, 2018; Stephen B. McHale, who is not a resident of the Severn River
33 Watershed, to serve on the Severn River Commission for a term ending on January 31,
34 2018; and Daniel J. Roche, who is not a resident of the Severn River Watershed, to serve
35 on the Severn River Commission for the remainder of a term ending January 31, 2017;
