ELECTRONIC MESSAGE BOARDS SHALL COMPLY WITH THE PROVISIONS OF §§ 1 17-6-501 AND 17-6-504 OF THIS CODE AND MAY NOT ADVERSELY EFFECT PROPERTIES 3 LISTED ON THE COUNTY INVENTORY OF HISTORIC RESOURCES, OR ON A SCENIC AND HISTORIC ROAD. THE PLACEMENT OF AN ELECTRONIC MESSAGE BOARD WITHIN SIGHT 4 5 OF A PROPERTY LISTED ON THE COUNTY INVENTORY OF HISTORIC RESOURCES OR ON A SCENIC AND HISTORIC ROAD SHALL MITIGATE ANY ADVERSE VISUAL IMPACT OF THE 7 ELECTRONIC MESSAGE BOARD IN A MANNER DETERMINED BY THE OFFICE OF PLANNING 8 AND ZONING.
