### A BILL ENTITLED

1 AN ORDINANCE concerning: Current Expense Budget – Supplementary Appropriation  
2 – North Beach Park Special Community Benefit District  
3

4 FOR the purpose of providing an appropriation of funds for the North Beach Park Special  
5 Community Benefit District for fiscal year 2021.  
6

7 BY amending: Current Expense Budget  
8

9 WHEREAS, § 4-7-103 of the County Code requires that budget requests for special  
10 community benefit districts, shore erosion control districts, and waterways  
11 improvement districts be submitted to the Office of the Budget by January 31 of  
12 each year; and  
13

14 WHEREAS, the fiscal year 2021 budget request for the North Beach Park Special  
15 Community Benefit District (“North Beach Park SCBD”) was not submitted to the  
16 Office of the Budget until September of 2020, and was not included in the fiscal  
17 year 2021 budget legislation; and

19 WHEREAS, under Section 712 of the Charter, upon the recommendation of the  
20 County Executive, the County Council may make supplementary appropriations  
21 from revenues received from anticipated sources but in excess of budget estimates  
22 and from revenues received from sources not anticipated in the budget for the  
23 current fiscal year, provided that the Controller shall first certify in writing that such  
24 funds are available for appropriation; and

26 WHEREAS, the County Executive has recommended a supplementary  
27 appropriation of certain funds, and the Controller has certified in writing that such  
28 funds are available for appropriation; now, therefore,

1 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*  
2 That the Current Expense Budget for the fiscal year ending June 30, 2021, is hereby  
3 amended by making supplementary appropriations from revenues received from sources  
4 not anticipated in the budget to the North Beach Park SCBD in the amount of \$18,020.  
5

6 SECTION 2. *And be it further enacted,* That this Ordinance shall take effect from the  
7 date it becomes law.
