5	Sustainable Community Overlay Area; and generally relating to zoning.

10	SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland,
11	That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

15	TITLE 14. OTHER OVERLAYS

17	18-14-603. Uses.

19	(a) Uses allowed. The uses allowed in redevelopment of a property in the Glen Burnie
20	Sustainable Community Overlay Area are the permitted and conditional uses allowed in
21	the R15, R22, C2, C3, C4, and W1 zoning districts. WITHIN THE GLEN BURNIE
22	SUSTAINABLE COMMUNITY OVERLAY AREA:
23	(1) WHEN A LIGE IS ALLOWED AS DOTH A DEDMITTED LISE AND A CONDITIONAL LIST
24 25	(1) WHEN A USE IS ALLOWED AS BOTH A PERMITTED USE AND A CONDITIONAL USE IN ONE OR MORE ZONING DISTRICTS, THE USE SHALL BE ALLOWED AS A PERMITTED USE
26	AND THE REQUIREMENTS OF TITLE 10 DO NOT APPLY; AND

ZONING DISTRICTS, THE USE SHALL MEET THE CONDITIONAL USE REQUIREMENTS OF TITLE 10, EXCEPT A REQUIREMENT THAT ADDRESSES BULK REGULATIONS, SUCH AS LOT SIZE, SITE AREA, COVERAGE, WIDTH AT THE FRONT BUILDING RESTRICTION LINE, 4 SETBACKS FROM LOT LINES, HEIGHT, DENSITY, FLOOR AREA RATIO, OR REQUIRED 5 PERCENTAGES OF USES, DOES NOT APPLY. 6

SECTION 2. And be it further enacted, That this Ordinance shall take effect 45 days 9 from the date it becomes law.
